

ARTICLES OF INCORPORATION

Comes now the undersigned for the purpose of forming a Not For Profit Corporation under the provisions of Arkansas Statutes Sections 64-1901, et seq:

1. The name of the Corporation shall be:

ARKANSAS SECURITY ALARM ASSOCIATION, INC.

2. The period of duration shall be perpetual.

3. The Corporation shall be organized for the following purposes:

An educational and co-operative corporation representing the interests of all persons, corporations and other entities engaged in or associated with the Security Alarm business in the State of Arkansas, including, but not limited to those subject to the Arkansas Alarm Systems Licensing Act.

4. The original Board of Directors shall serve until the next Annual Meeting in March of 1986, or until their successors are elected and qualified. The Board of Directors shall set the initial membership fee, and shall manage the affairs of the Corporation.
